Schmidt: The transition between administrations was historic this year. The perfect storm of a new administration and new administrative assistants is unlikely to happen again. Nieves: Does combining the funds guarantee the timing of disbursement? Schmidt: The total amount can never be processed until after AP scores are released. The years tied to the payments is also part of the confusion. When the payments went as planned, they were disbursed prior to the end of the calendar vear. Rosenberg: How much is this per teacher? Schmidt: Between \$4000 and \$5000.
