VI. Discussion & Action Items

- a. Discussion Item: State of Undesignated tax credit budget
 - Technical programs are preventing finance officer from viewing UHS budget data. Problem has been reported to TUSD tech services and has not yet been resolved.
 - ii. Last budget as of 10/4 \$35442.92 before incumbrances.Best guess as of now, \$26,000-\$27,000.Worst case scenario, \$19k-\$20k. (does not include end of year tax credits)
 - iii. Upcoming approximate \$14k to spend on stipends in April.
 - iv. Marchant, reports that Rincon side is having similar issues with accessing accounts.
 - v. Cislak reports she can not view school budget. District finance has not been helpful. Cislak suggests we write a letter as a school council to the governing board and auditor general.
 - vi. Band booster club is wondering if they need to sue to find money.
 - vii. Holtzman, encourages council to throw as much support behind Cislak's money autonomy and knowledge as possible. Offer to help draft letters.
 - viii. Mackenzie question about clout of parents outside the district compared to those who live within district boundaries. No difference when it comes to state tax credits.
 - ix. Vatthauer should we picket with the band?
 - x. Standridge asks for clarification of technical issues. Is visibility issue unique to us? We don't really know.
 - xi. Sinclair: impact on other clubs? Unknown. Varies from club to club.
 - xii. Braun has taken to bypassing site finance office and goes directly to district finance for dance expenditures.
 - xiii. Next possible steps: picketing at 1010, draft letter as a school council to governing board and auditor general, involve parents and alum in seeking information from the district. Widespread support for letter drafting.
